### SPECIFIC AUCTION RULES

Seven Mountains Media, Inc. through its Participating Radio Station(s), in conjunction with various sponsor(s) and/or auction item provider(s) (collectively, "Seven Mountains") is conducting a radio auction named as set forth above ("Auction"). Seven Mountains may conduct Auctions(s) on air or on its Web Site Address(s) from time to time which are conducted by Seven Mountains advertisers and other organizations that are not sponsored or endorsed by, and/or for which, neither Seven Mountains, nor its radio stations, participate ("Non-Seven Mountains Contest(s)"). For any Non-Seven Mountains Contest(s) please refer to the contest rules of the Non-Seven Mountains Auction Sponsor. Seven Mountains assumes no liability or responsibility in whole or in part for any Non-Seven Mountains Contest(s).

1) Void where prohibited or restricted by law. Must be 21 years of age or older to participate.

2) Beginning on the Effective Date, Seven Mountains Participating Radio Station(s) will conduct the Auction. If the participant with the winning bid declines the item(s) there will not be any alternate items(s) available in substitution and that item(s) becomes the property of Seven Mountains.

- The Auction item list will be made available to preview the week prior to the auction at [www.radioauctionnwpa.com](http://www.radioauctionnwpa.com)
- To bid on an item, a Participant(s) must make their bid online at [www.radioauctionnwpa.com](http://www.radioauctionnwpa.com)
- Most items will be up for bid as of 6am on March 10, 2025, and auction bidders will be able to start bidding at that time. Bidding will conclude at 12pm noon on Monday, March 17, 2025.
- Prices and availability of the items and/or services listed on [www.radioauctionnwpa.com](http://www.radioauctionnwpa.com) are subject to change without notice. The listing, description of, or reference to, a product or service on this Website does not imply that the product or service is presently available.
- If a bidder opts to take the Buy Now price, that item, service, or item number, will no longer be available for bidding and that bidder that takes the "Buy Now" option must pay for the item or service immediately. If payment is not received within 24 hours, that item or service will be placed back on to [www.radioauctionnwpa.com](http://www.radioauctionnwpa.com) and bidding will resume on that item or service, or Seven Mountains can contact the next highest bidder to buy the item or service.
- A starting bid may apply to items and services on the Radio Auction.
- Some items or services MAY have a "reserve" for a minimum bid amount that must be attained for the item or service to be sold on the Radio Auction.
- The Participating Radio Station(s) will contact the highest bidder by email for each item to notify them that they were the winning bidder. If the highest bidder does not respond within 12 hours, the Participating Radio Station(s) will then contact the next highest bidder until the item is purchased. All Notification about bidding, payment, and item claim is done by email.
- Neither Seven Mountains nor its Participating Radio Stations will be responsible for any technical difficulties regarding any attempted bid and/or any winning bidder contact notification attempt either during and/or after the Auction.
- The bidder understands and agrees that making a bid is *NOT* reversable and the bidder cannot retract any bids to purchase a good, service or gift certificate on [www.radioauctionnwpa.com](http://www.radioauctionnwpa.com).
- Certificates for each Auction item must be paid within 24 hours of the conclusion of the auction except for Buy Now items which must be paid for immediately after selecting the item.
- All Certificates for the items must be picked up and within 5 business days after the conclusion of the Auction on March 17, 2025 at the Meadville office only (900 Water Street, Downtown Mall, Meadville, PA 16335). **Pickup Times:** Starting Wednesday March 19<sup>th</sup>, our offices will be open for pickup of your item(s) certificate(s) from 10am to 4pm through Monday March 24<sup>th</sup>. For added convenience we will be open Saturday March 22<sup>nd</sup> from 9am till Noon at the 7 Mountains Meadville office location only. We will be closed on Sunday.
- Bidders must pay for their items by CREDIT CARD, DEBIT CARD or Paypal (some restrictions may apply for credit card users). If payment is not received within 24 hours the item will be offered to the next highest bidder. Except for Buy Now, the bidder must immediately pay for item upon selecting the item or service.

- If you wish to purchase gift certificates, goods, services, or auction items featured on [www.radioauctionnwpa.com](http://www.radioauctionnwpa.com) by credit card, you will be asked to supply certain information including credit card information. By making such a purchase, you agree to pay all charges (including any applicable shipping, credit card fees, handling and/or sales tax) incurred by users of your credit card.
- All bidders may be required to sign a release form when they come to pick up their items. Bidders will be given a certificate to take to the merchant to exchange for their auction item.
- Bidders must be cognizant that they will be purchasing a certificate to redeem in exchange for the item from a local vendor. There may be restrictions and/or conditions associated with taking title or delivery of an item or items. Any such restrictions will be disclosed on the radio auction website.
- Certain items on the radio auction may require a state/local/federal background check to obtain the item. Any and all cost associated with the background check is not included in the winning bid purchase and the cost is the responsibility of the winning bidder.
- The Radio Auction is not an Auctioneer.

3) Any questions or comments regarding the operation of the Radio Auction must be made in writing to Participating Radio Station(s) Operations Director at the Studio Address.

4) All Radio Auction Rules are subject to change at the sole discretion of the Participating Radio Station(s). Seven Mountains retains the right to cancel this Radio Auction for any reason at any time.

5) A copy of the official rules governing this Radio Auction as well as Seven Mountains General Contest Rules is available at the Participating Studio Address and on the Participating Radio Station(s) website address(s). Copies of the rules can be requested by sending a self-addressed stamped envelope to the Studio Address.

6) Except as specifically provided, Seven Mountains Auctions are generally open to US Residents, 21years or older. However, eligibility and minimum age requirements may vary depending on the specific Auction. Seven Mountains retains the right to change the Auction age on any item, on either a by item basis, or on a by Auction basis, or within any specific Auction. Unless otherwise provided in the Specific Auction rules for a Specific Auction or Auction item. No one under 21years of age or in debt to Seven Mountains Media, will be permitted to enter an Auction under any circumstance. Seven Mountains will delete and disqualify any entry whether on-line or by other means in compliance with the Children's Online Privacy Protection Act ("COPPA").

7) If Auction participation is by cellular, text or broadband all standard wireless carrier rates for the Participant(s) carrier will apply, and neither Seven Mountains nor its Participating Radio Stations will assume any responsibility for any fees for any communication to or from Seven Mountains or the Participating Radio Stations

8) Unless as otherwise specified by Seven Mountains in its sole discretion, Winners must execute and return any and all required documentation including but not limited to Auction participation, certificates and waiver and release forms required by Seven Mountains, in its sole discretion and as applicable to an Auction, within the time frame set by Seven Mountains, to Participant(s) provided contact email address and/or phone number. Winners must appear in person or as otherwise specifically set forth by Seven Mountains, with proper positive legal governmental issued photo identification acceptable to Seven Mountains, at its sole discretion, to claim any item(s) at the applicable Seven Mountains Radio Participating Radio Station(s) Studio Address, between 10am and 4pm or at a place and time as otherwise designated by or as otherwise required by Seven Mountains, or the items will be forfeited. No items(s) may be claimed by a third party on behalf of a bidder winner. Seven Mountains and its Participating Radio Station(s) reserve the ability at their sole discretion to choose alternate bidder winner(s) in the event of a disqualification or ineligibility.

9) Except at Seven Mountains sole discretion, items(s) will not be mailed out or delivered to winning bidders.

10) Winning bidders are responsible for any applicable federal, state, or local taxes or any incidental or title transfer taxes or fees associated with an Auction item.

11) Unless determined by Seven Mountains, in its sole discretion, no cash equivalent amount will be awarded for any Auction item(s). Each Auction item(s) is expressly limited to the item(s) announced by the Participating Radio Station(s), and does not include taxes gratuities or other potential items(s) related expenses. Auction items(s) will have a declared Value which is established by Seven Mountains and/or its item sponsors in their sole discretion. All items(s) are awarded "AS-IS" without any warranty of any kind by Seven Mountains and any such warranties are herein affirmatively disclaimed. Any Trip or Event Auction item(s) are subject to trip carrier or venue operator rules and restrictions. If an event or trip is cancelled, neither Seven Mountains nor its Participating Radio Station(s) will be responsible for that portion of the Auction item(s). Acceptance of a trip or event by a winning bidder constitutes an acceptance by them of the inherent risk of that Auction item(s). The winning bidder assumes such risk completely and will indemnify and hold harmless Seven Mountains and its Participating Radio Stations for any resulting damages or claims related thereto.

12) The Seven Mountains Participating Radio Station(s) may from time-to-time work in conjunction with concert promoters and various venues throughout our listening area to provide Participant(s) the opportunity to Auction tickets and sometimes meet performers backstage as part of an Auction. This opportunity is at all times subject to the sole discretion of the performer and the controlling venue and subject to change at any time. With this in mind, there may be situations where the Seven Mountains Participating Radio Station(s) and the promoter and/or the venue cannot be held liable for, including but not limited to: changes to the time, place, method, procedure, or cancellation of the event and or applicable Artist meet and greet sessions at any time.

13) Seven Mountains Participating Radio Station(s) and affiliated companies are not responsible for any claims, liabilities, or damages arising out of, or in conjunction with, any Non-Seven Mountains Auction(s) any typographical errors in the printing, administration announcement or Auction(s) awarding,

nor is Seven Mountains responsible for any malfunction of equipment or telephone systems, internet, or email, text or the cost of texting or otherwise transmitting their entry or participation during an Auction. The Seven Mountains Participating Radio Station(s) management has the final decision as to all matters related to the Auction in their sole complete and final discretion and at all times retains the right but not the obligation, in regard to all Auction matters including, but not limited to, the ability to, terminate, cancel, postpone, substitute, or modify the Auction, to qualify, disqualify or substitute bidder Participant(s), to award, re-award, rescind award and not to re-award any Auction item(s).

14) In the event of a local, regional or national emergency or power outage, or other event determined at Seven Mountains sole discretion, Auctions may be temporarily suspended, modified, or cancelled at the final, sole and complete discretion of Seven Mountains.

15) Auctions are void where prohibited or restricted by law.

16) If Auction Participant(s) are listening to the internet stream of a Seven Mountains Participating Radio Station(s), they are hereby advised that programming may be delayed affecting real time Auction participation. Participant(s) at no time should rely on streamed broadcasts in order to participate in any Seven Mountains Auction.

17) Any person or persons found to be in violation of any Auction rules, gain an unfair advantage, win using fraudulent means or exhibit unsportsmanlike, disruptive, harassing offensive or threatening behavior before, during, or after the respective Auction will be disqualified and any Auction items(s) will be forfeited and Seven Mountains will reserve the right at its sole discretion to not re-award any Auction items(s) for that Auction.

18) Any Auction(s) on the Participating Seven Mountains Radio Station(s) may be conducted via, but not limited to, the following methods: over-the-air, via telephone or text, on location at a business or event, via the Participating Seven Mountains Radio Station(s) website(s), or through social networks (i.e. Facebook, Twitter, and/or Instagram). Multiple Participant(s) are not permitted to share the same email address, social media account or text number. Only the authorized user of the email address social media account or the text number will be considered the bidder winner in the event of a dispute among multiple Participant(s) from such entries. While reasonable care will be taken, neither Seven Mountains nor its Participating Radio Station(s) nor any participating sponsor and/or Auction items(s) supplier can be held responsible for the non-delivery, delay or loss of an entry. Auction entries will become the property of Seven Mountains and will not be acknowledged or returned.

19) If you are accessing these rules on, or participating in this Auction from, a Seven Mountains Participating Radio Station(s) Website(s), you are deemed to have specifically agreed to the Seven Mountains Website(s) Terms of Use and to the use of your personal information as described in the Privacy Policy contained on the Website(s). Should Seven Mountains or its Participating Radio Station(s) determine that there is any suspected or actual evidence of any fraud that effects the integrity of an Auction conducted in any form and/or through any medium, Seven Mountains reserves the right but not the obligation, in its sole discretion to modify, suspend, or terminate the Auction.

20) By participating in the Auction and/or accepting the Auction items(s) to be bestowed from the Auction, the Participant(s) acknowledge that there could be certain considerations and/or risks associated with the Auction and/or the bidding of items(s) and further acknowledges that it is the Participant(s) responsibility to abide by all terms of general and/or Specific Auction Rules (as applicable) and exercise any safety precautions associated with Auction participation and/or the winning of Auction items(s). Therefore, for good and valuable consideration the sufficiency of which is hereby acknowledged by the Participant(s) to the Auction, and his or her heirs, agents and assigns agree to hold harmless Seven Mountains and its respective radio station(s), affiliates subsidiaries, employees, agents, owners, officers, directors Auction items(s) Auction item(s) provider(s) and/or sponsor(s), event location operators and their respective assigns from any and/all claims, liabilities, demands, attorney's fees or other unforeseen acts of any kind whatsoever, including but not limited to any restrictions or requirements of providers, of the Auction participation and judging, and/or Winning or awarding of Auction items(s), and any other consideration, that may result from, the Auction participation and/or the bidding winning of Auction items(s).

21) By participating in the Auction, all Participant(s) grant Seven Mountains the exclusive permission to use their names, characters, images, voices and likenesses submitted content, ideas or other submissions in connection with the Auction and waive any claims to royalty, right or remuneration for such use. Participant(s) also hereby waive any right to inspect or approve the finished copy of any media, broadcast, advertising material and/or any Seven Mountains use in connection with their Auction participation and/or bidder winning of Auction items(s). Participant(s) also affirmatively represent that any submissions are their own work and does not infringe on any copyright, trademark or other intellectual right of any other person and will indemnify Seven Mountains for any breach of that representation.

**The above Auction Rules may be amended, supplemented, or modified in all or part for a specific radio station or station(s) Events/Contests/Activities from time to time by Seven Mountains in its sole discretion. Seven Mountains at all times reserves the right to amend/supplement and/or modify these Auction Rules with specific rules which shall be made available by the Seven Mountains radio station as appropriate and in the Seven Mountains radio station(s) sole discretion. Listeners and potential Auction Participant(s) are urged to acquaint themselves with these specific Auction rules in advance of their participation. Where specific Auction rules are in place for a particular Auction, those specific Auction rules shall control over where different from any general Auction rules.**
